Code of Conduct

The MetroWest YMCA is committed to providing a safe and welcoming environment for all members and guests. To promote safety and comfort for all, we ask individuals to act appropriately at all times when they are in our facility or participating in our programs. We expect persons using the YMCA to behave in a mature and responsible way, and to respect the rights and dignity of others. Our Code of Conduct does not permit language or any action that can hurt or frighten another person, or that falls below a generally accepted standard of conduct.

Prohibited actions specifically include:

- Inappropriate attire. Appropriate attire must be worn at all times.
- Angry or vulgar language, including swearing, name-calling or shouting.
- Physical contact with another person in any angry or threatening way.
- Any demonstration of sexual activity or sexual contact with another person.
- Harassment or intimidation by words, gestures, body language or any menacing behavior.
- Theft or behavior that results in the destruction of property.
- Carrying or concealing any weapons or devices or objects that may be used as weapons.
- Using or possessing illegal chemicals or alcohol on YMCA property, in YMCA vehicles, or at YMCA sponsored programs.
- Any other conduct of an inappropriate, threatening or offensive nature.
- Loitering is not permitted in or outside the YMCA.
- Smoking is not permitted in or outside the YMCA. The YMCA and its property is a smoke-free environment.
- Cell phone use, including texting, is prohibited except for in designated areas.
- The use of audio, camera, and video recording devices is prohibited in all MetroWest YMCA facilities. Those wishing to use audio, camera or video recording devices must receive written consent in advance from a designated YMCA Director.
- Allowing or assisting unauthorized persons access to the facility is prohibited.

Members and guests are encouraged to be responsible for their personal comfort and safety, and to ask any person whose behavior threatens their comfort to refrain in a courteous and respectful manner. If a member or guest feels uncomfortable in speaking with the person directly, they should report the behavior to a staff person or the Building Supervisor on duty. YMCA staff members are eager to be of assistance. Members and guests should not hesitate to notify a staff member if assistance is needed. In order to be able to carry out these policies, we ask that members and guests identify themselves to staff when asked.

The Branch Executive will investigate all reported incidents. Suspension or termination of YMCA membership privileges may result from a determination by the Branch Executive if in his/her discretion a violation of the YMCA Member Code of Conduct has occurred.

By participating in the YMCA Nationwide Membership Program, I agree to release the National Council of Young Men's Christian Associations of the United States of America, and its independent and autonomous member associations in the United States and Puerto Rico, from claims of negligence for bodily injury or death in connection with the use of YMCA facilities, and from any liability for other claims, including loss of property, to the fullest extent of the law.

Monthly Draft Authorization Agreement

I have given authority to the bank or credit card issuer named above to honor preauthorized debits drawn by you on my account for membership payments as indicated above. It is understood that the draft on my account shall constitute valid notice of such payment due on my membership. When the bank or credit card issuer honors the payment, my account statement shall constitute receipt for payment. Should any preauthorized credit card or bank draft not be honored by the issuer when received by them, then it is understood that they payment has not been made and I am responsible for making the payment directly to the MetroWest YMCA. The bank/credit card draft is a continuous membership plan. I understand that my membership will remain in effect permanently or until I initiate its termination. **I understand that if I wish to terminate or change my membership in anyway, I must give the MetroWest YMCA a 15 day written notice prior to my draft date.** Should my draft not be honored by my bank for any reason, I understand that the MetroWest YMCA will automatically resubmit the draft for payment. I understand that after two(2) unpaid drafts, the MetroWest YMCA will terminate my membership until I have brought all payments up-to-date.
